

MOUNTAIN STATES DIVISIONAL CIRCUIT FINALS \$1000 ADDED GROUND RULES 2024

Will be hosted by the Jody Motley Memorial on Saturday September 14, 2024 at The Ranch Arena in Loveland Colorado. To compete in the DC Card Holder Race it is required that you enter the JMM Open Race for that day. Your time will be rolled to the JMM Open Race for that day. Regarding the JMM Open Race for that day you must pay in cash prior to competing in the DC Card Holder Race. The DC Card Holder Race will follow the youth race, see the JMM schedule for time. We will drag after 5 runners.

Top 12 in the 2024 Mtn. States DC standings as of August 15, 2024 are invited. Others below the 12th position in the standings are encouraged to enter but not guaranteed to run. Qualification cut off is August 15, 2024. Top 12 in the 2024 Mtn States DC standings can be found at www.wpra.com.

If the top 12 don't all enter finals, we will drop down to the next person in the 2024 Mtn States DC standings **who entered the Mtn States DC Finals.**

Entries for DC finals by EMAIL on Monday August 26th at 8 am Mtn time and close on Monday August 26th at 8 pm, Mtn time. All entries must be emailed to shelly@wpra.com with the contestant's name, card number, and phone number. You will receive an email confirmation of your entry. If you do not receive an email you are not entered. No entries will be taken by phone.

Finals will be 1 run, with entry fees of \$55 and a \$10 office charge. Fees are required to be paid prior by mail and received by September 6th. Mail entry checks payable to WPRO Mountain States Awards, PO BOX 4051 Cheyenne, WY 82003, Venmo Dana-Norris-2 or PayPal murrellldr@yahoo.com. If the entry fee is not received by the deadline, we will drop down to the next eligible person who entered.

Once entry fees are paid there are no releases or refunds. There are no exceptions. You must check in by 9:00am the day of the race with Shelly Vossler or Wendy McKee. If you do not check in your spot will be given to the next eligible person who entered and is present at the race. WPRO dress code enforced for competition and awards presentation immediately following competition.

To compete in the DC Permit Race it is required that you enter the JMM Open Race for that day. The DC Permit Race is a standalone race. Your time will be rolled to the JMM Open Race for that day. Regarding the JMM Open Race for that day you must pay in cash prior to competing in the DC Permit Race. The DC Permit Race will follow the DC Finals race, see the JMM schedule for time. We will drag after 5 runners.

Permit finals late entries open Tuesday August 27th at 8:00am Mtn time and close Tuesday August 27 8:00pm Mtn time. All Permit entries must be EMAILED to shelly@wpra.com with the contestant's name, card number, and phone number. You will receive an email confirmation of your entry. If you do not receive an email, you are not entered. No entries will be taken by phone. If you have already pre-entered, your entry is still good.

Finals will be 1 run, with entry fees of \$50 and a \$0 office charge. If you have already paid you are good, fees for Permit LATE Entries are required to be paid prior by mail and received by September 7th. PayPal murrelldr@yahoo.com. If an entry fee is not received by the deadline, you will be drawn out of the permit finale.
